Tournament waters will be the Arkansas River, canals, and creeks connecting to the Arkansas River. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants.

**FISH LIMITS**

Pro-Angler: 5 fish / Co-Angler: 3 fish / 14" minimum length

Balance deadline dates are the dates the balances are due. You will not receive any further notices on balance due. It is the anglers' responsibility to be sure payment is made by the deadline date.

**Deposits are non-refundable and non-transferable regardless of date of cancellation.** Any balance of the entry fee paid in excess of the deposit will be refunded only if notification is made to the B.A.S.S. Tournament Department prior to the balance deadline date. Anglers on waiting list should not pay balance until contacted by tournament department.
